Nominations to run for CEF's 2021 Board are due on Monday** – If you're interested in running for a position on CEF's 2021 Board of Directors, nominations are due by COB this Monday, November 2 - the nomination form is attached. In December, CEF members will elect 7 members to CEF's 2021 Board of Directors: three officers who will serve a one-year term and four other Board members who will serve two-year terms. The new president will appoint two additional members.

- **Sample education funding tweet for this week** – This week CEF (@edfunding on Twitter – follow us if you haven't already!) [tweeted](#) a new chart showing the pandemic relief education funding already enacted and in several House and Senate bills. That chart is attached above, and below is a sample tweet anyone can use and modify to reflect your priorities.
 - **Sample tweet** – A top priority for Congress must be providing more support for education, a vital need right now. The House has passed bills with up to \$225 billion for education, but the needs are only growing.
