Share Your Story of Why Education Funding Matters to You and Urge Congress to Support the President's Requested Historic Investments in Education

Why this matters now

- **The President requested a large increase in federal investments in education and Congress has yet to complete its work on that funding for fiscal year 2023.** The President requested a \$13 billion increase in appropriations for Department of Education programs plus over \$20 billion in new mandatory funding for the two largest programs – Pell Grants for college students and Title I to support low-income schools. The President also requested big increases for Head Start, child care, and other education-related programs. These investments would have a real impact along the education continuum to help address long-standing needs and the new challenges brought on by the pandemic. **Now is the time to urge Congress to increase education funding by saying why education funding matters to you!**

What you can do

- **Make a short video or write a message** telling your two U.S. Senators and your Representative about your experience in the education community (your school, college, child care, or other education program). Tell Congress how a greater federal investment in education would make a big difference (see sample message below).
- **Share the video or written message on Twitter, Facebook, or Instagram** (see sample post below).

Sample message to record or write out

Twitter Tips (CEF account = @edfunding):

- Your tweet can't exceed 280 characters (that counts 23 characters for any link that you include). Your video or photos don't count as characters, though.

Instagram Tips (CEF account = @edfunding):

- Make sure your video is under the 60-second time limit
- Mark your hometown as the location of the video so the Member of Congress knows you are a constituent!

Facts about education funding:

- Congress hasn't voted on FY 2023 appropriations yet. The President requested large increases for education and education-related programs. It's important for Congress to hear that the public supports greater investments for education, from early education to post-secondary education.
- Funding for the Department of Education was stagnant for years, and despite an increase for this year is still \$12 billion below the 2011 level in inflation-adjusted dollars.
- Education funding accounts for only about two percent of the regular federal budget, yet those investments have vital immediate and long-term returns that benefit society as a whole. The President's budget increases education to 3.6 percent of the federal budget in 2023.
