## I. Policy Intelligence and Education News

- **House passes CR through December 3 that Senate is unlikely to pass – Fiscal year (FY) 2021 ends in 8 days and Congress is having trouble agreeing on how to extend government funding while it continues to work on full-year FY 2022 appropriations bills.** Last night on a party-line vote, Democrats in the House passed a continuing resolution (CR) extending current funding until December 3; the bill also suspends the debt ceiling until December 2022 and includes emergency funding for disaster relief and resettlement assistance for displaced Afghans. The bill requires 60 votes to pass in the Senate (to end a potential filibuster), but Republicans have vowed not to support an increase in or suspension of the debt ceiling – something that will have to happen in the next month or the US will no longer be able to borrow and will begin to default on its obligations, with catastrophic economic repercussions. Yesterday Senate Republicans released their own CR, which does not address the debt ceiling and contains foreign aid funding that progressive Democrats oppose. How this faceoff ends is uncertain, but nobody wants to shut down the government on October 1, and Congress clearly needs more time to work on FY 2022 appropriations bills, as the Senate has not agreed on how to allocate funding among the 12 government funding bills.
- **Reconciliation and bipartisan infrastructure framework also at a stalemate in the House**  
– Progressive and moderate Democrats in the House continue to disagree on the sequencing of passing the bipartisan infrastructure framework that the Senate has already passed and a larger reconciliation bill containing “human” infrastructure investments – including hundreds of billions for education and related programs. House leadership previously committed to bringing the infrastructure bill to the floor for a vote by Monday, September 27. However, progressives say they

won't vote for that bill unless they can also vote for the reconciliation bill, which will not be ready by Monday. In fact, the reconciliation bill is likely weeks away, as Democrats negotiate behind the scenes to possibly pare back the size of the House committee proposals to garner support from all the Senate Democrats, some of whom have balked at the price tag.

- **Staff change at the House Labor-HHS-Education Appropriations Subcommittee** – Jared Bass has left the House Labor-HHS-Education Appropriations Subcommittee Democratic staff to be Senior Director for higher education at the Center for American Progress. Philip Tizzani, who has been handling K-12 education for the Subcommittee, is now also taking on the higher education portfolio.
